There are lots of failures by our Department of Foreign Affairs specifically in OUMWa to provide assistance to Mr. Mabanto.

The Embassy and DFAs reports are all nonsense. The reason why Jamil still languishes in Jail is that the government agency assigned to help us did not attend well to jamil's case.

Jamil would like to ask the Medical Reports of Benjamin Cruz Death but the Embassy and OUMWA gave many nonsense reasons just to say no to Jamil's request.

They always reasoned as if they are too concern for Jamil Mabanto. But the main reason why they do not give those medical reports is that they just want to cover something.. And that something is their negligence

Now, I am asking for your help Mrs. President to advise this government agency that Jamil Mabanto has the right to have a copy of the 2 medical reports.

We talked with the ambassador, we talked with OUMWa Manila but they never want to give.

Mrs. President, I was one of those people who helped Joselito Alejo to file for his compensation for his acquittal and 6 years stay in Jail.
